

GP Commissioning Poll

Final Results
July 2011

INTRODUCTION

The initial results of Sheffield LMC's GP Commissioning Poll were formally presented at the LMC meeting on Monday 9 May 2011 and subsequently published on the LMC's website.

Analysis of the free text parts of the poll then took place. The results that follow are presented as citywide responses and responses by consortia. The overall response rate is also shown by contractual type, as suggested by the committee.


Some practices in the Central Consortium replied to the poll, confirming that they would not be completing the poll. There was some difficulty in deciding whether this constituted a response or non-response. Therefore, these doctors have been classed as 'Central Stance'.


MAIN CONCLUSIONS

- 461 Sheffield GPs were polled.
- The response rate of completed polls was 48%.
- The overwhelming majority of responders wanted to see a single consortium model for Sheffield, with either formal or less formal locality links. This was confirmed in the free text responses received for question 1.3 'What would your preferred structure(s) be for the city?'
- The overwhelming majority wanted an election for clinical leadership and an assessment of competencies of candidates.
- Only a minority thought NHS Sheffield (NHSS) should be involved in appointing commissioning leaders, compared to the number thinking the LMC should.
- Nearly all responders thought that the GP Commissioning Board should consist of GPs.
 Most also thought there would be a role for Practice Managers and, fewer, but still a
 majority, thought Practice Nurses would have a role.
- Three quarters of responders favour formal LMC representation with no vote on a commissioning board.
- More than half of responders felt inadequately informed about changes planned by the White paper (now the Health and Social Care Bill) and nearly the same number thought that their views on current commissioning intentions are not accurately reflected.
- A small number of doctors felt that they could be involved as clinical leaders.




Responses Received By Consortia




Responses Received By Contract Type




1.1 Do you wish to see a one consortia model for Sheffield with one Accountable Officer? Citywide Response



1.1 Do you wish to see a one consortia model for Sheffield with one Accountable Officer? Responses by Consortia




1.2 Do you favour any locality links? Citywide Responses




1.2 Do you favour any locality links? Responses by Consortia




2.1 Do you wish to see an election for clinical leadership prior to April 2013? Citywide Response




2.1 Do you wish to see an election for clinical leadership prior to April 2013? Response by Consortia




2.2 Should candidates' commissioning competencies be assessed prior to appointment? Citywide Responses






2.3 Who should appoint such leaders? NHS Sheffield? Citywide Responses












2.4 Who should be on the GP Commissioning Consortia Board? GPs? Citywide Responses




2.4 Who should be on the GP Commissioning Consortia Board? GPs? Responses by Consortia




2.4 Who should be on the GP Commissioning Consortia Board? Practice Managers? Citywide Responses










2.4 Who should be on the GP Commissioning Consortia Board? How Many? Citywide Responses

- However, there is a clear steer that GPs should form the majority on the Board, with only a few suggesting an equal mix of GPs, Practice Managers and Practice Nurses.


2.5 Do you favour formal LMC non-voting representation on a commissioning board? Citywide Responses




2.5 Do you favour formal LMC non-voting representation on a commissioning board? Responses by Consortia




3.1 Do you feel adequately informed about changes planned by the White Paper? Citywide Responses




3.1 Do you feel adequately informed about changes planned by the White Paper? Responses by Consortia




3.2 Do you feel your views on current commissioning intentions are accurately reflected? Citywide Responses




3.2 Do you feel your views on current commissioning intentions are accurately reflected? Responses by Consortia




3.3 Would you be prepared to commit to clinical commissioning work as a clinical leader? Citywide Responses




