LICENSING AND REVALIDATION OF GPS

Further to the article in the May 2009 edition of the LMC newsletter, the General Medical Council (GMC) has announced that from 16 November 2009, all doctors will need a licence in order to practise medicine in the UK. The GMC has written to all registered doctors asking them to decide whether or not they want a license when licensing is introduced. GPs can either respond by post (in the envelope provided) or electronically via the GMC's secure online facility at:

www.gmc-uk.org/decide

GPs will be prompted to enter their GMC reference number and the unique survey reference number contained in the letter from the GMC.

The GMC also recently published Revalidation: Information for Doctors and Frequently Asked Questions, which covers a wide range of issues, including the implementing timetable for revalidation, the information that doctors will have to collect as part of the process, how revalidation will work for doctors in different types of medical practice, and the role of the Responsible Officer. STORAGE OF VACCINES IN PRIMARY CARE

All practices should have recently received an alert from NHS Sheffield regarding a number of serious untoward incidents (SUI) relating to the storage of vaccines in primary

As you will be aware, vaccines may lose their effectiveness quickly if they become too hot or cold at any time during transport or storage. This may result in the failure of the vaccine to protect, as well as resulting in vaccine wastage.

NHS COMPLAINTS IN ENGLAND: REGULATIONS AND PRINCIPLES

FIT NOTE CONSULTATION

The Department for Work and Pensions (DWP) is undertaking a consultation regarding the proposed introduction of a "fit note" system.

It is estimated that every year around 350,000 people leave work to claim health-related benefits and 172

million working days are lost due to sick absence.

GPs are, in most cases, the primary source of advice and guidance for individuals with a health condition. Evidence shows that GP advice is pivotal to an individual's decision on returning to work. However, the proposal to introduce fit notes has raised a number of concerns and the LMC would encourage GPs to access the consultation document and offer their views.

THE SHEFFIELD WATCH IT PROGRAMME

NHS Sheffield has commissioned a new community based weight management service for overweight and obese children aged 7-14 and their families. The Sheffield Watch It Programme will be delivered by ZEST and aims to support and empower overweight and obese children to achieve long term weight loss.

Families can self refer and or be referred to the service by their GP if the child has a BMI at or above the 91st centile. The service will work with children and families and it will be offered in a range of community venues across the city.

Each child entering the service will undergo an initial assessment by ZEST. Where the child has a BMI at or above the 98th centile a further health check is required from their GP before they can begin the programme. The purpose of the check is to identify any comorbidities related to the obesity to ensure that the child's involvement in the service is safe and appropriate.

THE NATIONAL CHILD MEASUREMENT PROGRAMME (NCMP)

The Department of Health's National Child Measurement Programme (NCMP) takes place during every academic year and is led locally by NHS Sheffield. The Sheffield School Nursing Service weighs and measures children aged 4-5 (Reception year) and 10-11 (Year 6). The Department of Health (DH) has introduced a new requirement for the 2008-09 academic year to inform Year 6 parents/carers of their child's weight status. A standard parent feedback letter has been produced by the DH which NHS Sheffield is required to use.

The NCMP is being carried out during the summer term (May-July). Parents/carers will therefore begin receiving the letters from June 2009. The NCMP is not a screening programme and therefore children will not automatically be referred on the basis of this information.

Parents/carers will receive their child's weight status based on four categories determined by the clinical cut offs for underweight, healthy overweight weight, and overweight (obese). All parents of overweight or obese children will be signposted to general healthy lifestyle advice and provided with contact information for the Sheffield School Nursing Service and the Sheffield Watch It Programme into which self refer. they can Parents/carers of underweight children will be signposted to general health lifestyle information and advised to contact their GP for advice if they remain concerned. Further information to support GP practices should they receive any queries from concerned parents/carers will be made available shortly.

GP PRACTICE SUPPORT FOR COLLECTING FEEDING STATUS AT 6-8 WEEKS

With the support of GP Practices, Sheffield has met the Care Quality Commission (CQC) target to achieve at least 85% of "infants with breastfeeding status recorded at 6-8 week check" by March 2009. However, of the overall data coverage, only 79% was achieved through GP Practices returning fully completed carbon copies (flimsies) to Child Health Services.

For 2009/10, NHS Sheffield needs the continued support of all GP Practice staff (including GP locums and temporary staff) to get the feeding status at 6-8 weeks recorded for 90% of infants. To achieve this it is vital that:

- Carbon copies (flimsies) are completed fully and clearly, including information on feeding status
- Completed carbon copies are quickly returned to Child Health Services, Centenary House using pre-printed address labels.

To assist Practices in briefing staff, a one page flowchart of the process will be distributed to all Practices by the end of June.
