GPC SESSIONAL GPS REPRESENTATION WORKING GROUP REPORT

In May 2009 the General Practitioners Committee (GPC) set up a working group to review the way that sessional GPs are represented by the BMA and at a local level, and to consider ways that representation could be improved. To support its work, the working group commissioned the BMA Health Policy and Economic Research Unit to carry out an extensive research programme.

The Sessional GP Representation Research Programme had four strands:

GOODWILL AND DISPENSING

DENTAL PROBLEMS: GP RESPONSIBILITIES

RCGP LEADERSHIP PROGRAMME

PRACTICE PURCHASE OF SEASONAL INFLUENZA VACCINE

- a comprehensive survey of over 1,800 sessional GPs;
- a series of interviews with sessional GPs on the representation of sessional GPs within the BMA and the GPC;
- a survey of the representation of sessional GPs on LMCs;
- a consultation of external stakeholders on the way in which the BMA represents sessional GPs

The evidence demonstrated that many sessional GPs feel that improvements are required to the way in which they are represented. A working group report has been published, which details the findings, changes that have been or will be made within the BMA and guidance / recommendations for sessional GPs and LMCs. STRIKING A BALANCE: WHAT MATTERS MOST IN GENERAL PRACTICE

The GPC is seeking the views of the public, the professions, patient groups and health charities on four key issues facing general practice and patients:

- the evolving practice team;
- getting a suitable appointment;
- care and treatment outside normal working hours;
- continuity and coordination of care in the modern NHS.

The consultation discusses challenges in each of these areas before setting out some questions intended to provoke thought and debate. Responses will assist the GPC in working with policy-makers at all levels to protect, develop and strengthen general practice in line with patient, public and GP priorities.

In particular, the GPC has requested LMC assistance in raising awareness of this consultation with practices, with a request that practices pass on details to their patient participation groups.

NOTIFICATION OF INFECTIOUS DISEASES

Under the Public Health (Control of Diseases) Act 1984 (as amended), GPs are required to notify the proper officer of the local authority when they have reasonable grounds for suspecting that a patient:

- has a notifiable disease as listed in Schedule 1 of the Act;
- has an infection (not listed in Schedule 1) which, in the view of the GP, presents, or could present, a significant harm to human health; or
- is contaminated in a manner which, in the view of the GP, presents or could present significant harm to human health.

There was previously a nominal fee set out in the Act for such notification, however this fee has now been removed by recent regulations. Nevertheless, GPs must still continue to notify.

The BMA was consulted on the removal of the fee and objected to it. However, the legislative change was made.

IMPROVING GP SERVICES

In July 2009 the GPC issued guidance entitled *Focus on the Department of Health's 'Improving GP Services' guidance*, which made reference to a number of proposals.

GOODWILL AND DISPENSING

Sale of goodwill is illegal if it relates to, or is claimed on, the purported sale of essential services, although enhanced services are exempt from this. However, there has been some confusion whether GPs can sell goodwill in terms of the dispensing element of their contracts or not. RCGP LEADERSHIP PROGRAMME

Sheffield LMC has been contacted with a request to make Sheffield GPs aware of the RCGP Leadership Programme. The programme is run over a 12 month period and includes a mixture of 'class room' work, tutorial support, on-line study and residential workshops.

The programme has proved useful to GPs who have taken on roles such as Practice Based Commissioning leads, chairs or members of PECs, clinical governance leads, examiners, GP trainers, appraisers, GPwSIs, members of collaboratives, LMC members, and those involved with GP education. PRACTICE PURCHASE OF SEASONAL INFLUENZA VACCINE

As reported in NHS Sheffield's GP e-bulletin w/e 30th April 2010, Sheffield Area Prescribing Committee (APC) has been made aware of new intradermal seasonal

influenza vaccines being marketed in Sheffield.

In view of the current financial deficit in Sheffield, it was felt appropriate to make practices aware of the differential cost to the health economy of bulk purchase of this vaccine. The new intradermal vaccine is marketed at £9.05, compared to standard intramuscular influenza vaccines costing £4.49 and £5.22. This would obviously have a significant impact on the cost of the influenza vaccination programme to Sheffield.

NATIONAL CHILD MEASUREMENT PROGRAMME (NCMP)

The Department of Health's National Child Measurement Programme (NCMP) takes place during every academic year and is led locally by NHS Sheffield. The Sheffield School Nursing Service weighs and measures children aged 4-5 (Reception year) and 10-11 (Year 6).

The Department of Health (DH) has introduced a new requirement for the 2009-10 academic year to inform both Reception Year and Year 6 parents/carers of their child's weight status. A standard parent feedback letter has been produced by the DH which NHS Sheffield is required to use.

The NCMP is being carried out during the summer term (May-July). Parents/carers will therefore begin receiving the letters from June 2010. The NCMP is not a screening programme and therefore children will not automatically be referred on the basis of this information.

Parents/carers will receive their child's weight status based on four categories determined by the clinical cut offs for underweight, healthy weight, overweight and very overweight (obese). All parents of overweight or obese children will be signposted to general healthy lifestyle advice and provided with contact information for the Sheffield School Nursing Service.

Parents/carers of overweight and obese Year 6 children will be signposted to the Sheffield Watch It Programme into which they can self refer. Parents/carers of overweight or obese Reception Year children will be signposted to parent/family sessions run by Carnegie Weight Management delivered through the Sheffield Let's Change4Life Programme.

Parents/carers of underweight children will be signposted to general healthy lifestyle information and advised to contact their GP for advice if they remain concerned.

FALLS AND BONE HEALTH AUDIT FOR OLDER PEOPLE

As reported in NHS Sheffield's ebulletin w/e 11 June 2010, NHS Sheffield, Sheffield Primary Care Trust, and Sheffield Teaching Hospitals NHS Foundation Trust are participating in the Royal College of Physicians National Clinical Audit of Falls and Bone Health for Older People 2010.

This audit will look at care given to 60 patients who have sustained an injurious fall. Follow up of patients identified will take place from September to December 2010.

The audit should not involve work for practices other than access to records
