# HEPATITIS B VACCINATION: RENAL PATIENTS

Further to the article in the November LMC newsletter, we contacted the Renal Unit at the Northern General Hospital (NGH) to clarify the requirement that Renal Units provide high dose Hepatitis B immunisation to renal patients.

We subsequently received a helpful update from Dr Sarah Jenkins, Consultant Nephrologist and Clinical Director of the Renal Unit, noting that when they were directed to deliver the service, as a response to the national shortage of vaccines they introduced a 'rapid' response mechanism for high priority renal patients.

Delivery of the new full vaccination service has required the establishment of new systems, including appropriate tracking, staffing and staff training. This is now in place, and patients under the care of the Renal Unit with GFR<20 (and are considering renal replacement therapies) and those already on renal replacement therapies will be vaccinated in secondary care. The Renal Unit is preparing a communication to primary care, noting that if these patients request vaccination at their GP practice, they should be directed to the Renal Unit.

This is a change in policy which should alleviate GP and Practice Nurse time.

# **PRIMARY CARE INDEMNITY SURVEY**

The Department for Health and Social Care (DHSC) has published the results of their Ipsos Mori indemnity survey, designed to help the department understand current indemnity arrangements within General Practice, informing the development of the new state backed scheme:

As over half of the GPs surveyed were unaware of what kind of cover they had, the DHSC is encouraging GPs to be proactive in checking their current and previous indemnity coverage. GPs with claims-paid or claims-made indemnity policies will be required to purchase run off cover separately themselves to ensure they are fully indemnified for any claims that may occur.

The DHSC has published FAQs on the scheme, which will be added to as the final details of the scheme remain subject to ongoing discussions.

Concerns have been expressed about the answer in the FAQ relating to funding arrangements. This was reflected in comments at the Conference of England LMCs on Friday 23 November, and led to an emergency motion which was passed unanimously:

That conference is outraged and deeply concerned at the statement of 22 November 2018 from the Department of Health and Social Care that the newly state backed indemnity scheme may be funded from "existing resources allocated for general practice" and instructs GPC England to work with the government in ensuring that:

- 1. the scheme is supported by new funding;
- 2. no GP is financially disadvantaged by a change to a state backed scheme;
- 3. all GPs and practices are protected from any future increases in the cost of the state backed scheme.

## SUTURE DRUG TARIFF UPDATE

Information provided by Dr Soon Lim, President and Education Lead, Association of Surgeons in Primary Care (ASPC)

Many GP practices provide minor surgery and, therefore, use Ethicon sutures which are then reimbursable under the Personal Administration payments. Not every available suture is reimbursable and only those on the list and for which an FP10 with the correct product code is generated and submitted are recognised by the NHS Prescription Services.

Ethicon, part of the Johnson and Johnson group, have decided to standardise their product codes globally in Project Vantage, which has resulted in reports of GPs not being able to buy the sutures they are used to using as suppliers have run out of old stock bearing the old product groups.

Practices which carry out minor surgery will need to note these changes in preparation if they wish to continue to claim for the sutures used.

- What constitutes an electronic signature (e-signature)?
- Can e-signatures be used instead of wet-ink signatures?
- Examples of documents where I can use an e-signature.
- Other considerations.

# WITNESS SUMMONS AND COURT ORDERS

The note, which is not a substitute for specific legal advice, covers:

- Is a witness summons or court order requiring practices to produce patient records the same as a Subject Access Request (SAR)?
- Must practices respond to a witness summons or court order to produce patient records?
- What should a practice do if it does not understand the terms or scope of the witness summons or court order?
- Should a practice redact third party data appearing in patient records before producing them to the court?
- Can a practice claim its costs of complying with a witness summons or court order?

# CARE QUALITY COMMISSION (CQC) REGISTRATION PROCESSES REVIEW

A recent updated from the CQC noted that they are transforming their approach to registration, with the aim of streamlining and improving processes to make them quicker and easier for providers. They are looking to talk to aspiring or newly registered managers to make sure these changes meet their needs, stating that this is an opportunity to:

• influence the future of managing registration and creating a smoother experience;

• share feedback on experiences directly with CQC staff who are developing the approach.
