However, this has not happened and practices across the country have been reporting their concerns about the future of their services to LMCs and to the General Practitioners Committee (GPC). As a result, in an open letter to Simon Stevens, Chief Executive of NHS England, Chaand Nagpaul, Chair of the GPC has demanded urgent action to protect practices.

HEALTH AGEING QUESTIONNAIRE

The EU has released two linked questionnaires relating to healthy ageing which require the input of doctors and elderly patients.

The survey for doctors aims to assess the awareness of doctors of functional performance (capacity), decline and frailty related to ageing and the possibilities to prevent/delay the onset of these issues and/or mitigate their consequences.

The survey for patients aims to assess the awareness, opinion and attitude of the population aged over 60 regarding healthy and active ageing. The Standing Committee of European Doctors has requested that the GPC circulates details.
