PRIVATE FOSTERING

Following a number of queries from practices, LMC and Sheffield City Council (SCC) representatives met to clarify the role of private foster carers and SCC requests for medical information identifying concerns regarding safeguarding.

Agreement was reached on:

- the circumstances in which SCC would contact GPs,
- what information would be requested,
- the circumstances in which a fee could be charged.

NEW MEDICINE SERVICE

As you will be aware from the November 2011 edition of the LMC newsletter, the New Medicine Service commenced on 1 October 2011.

This is a national initiative involving pharmacies, whereby patients started on new medications in 4 disease groups are recruited and followed up to try to improve medicines adherence and compliance and decrease NHS waste.

# PRACTICE NURSE INDEMNITY

Following the article in the November 2011 edition of the LMC newsletter, advising practices to check their indemnity arrangements, concerns have been raised with the LMC that some practices might not be aware of the full implications of the changes.

The Royal College of Nursing (RCN) wrote to their members last year, informing them that indemnity for work undertaken in practices will be provided through the employers' indemnity policy, rather than through the RCN, from 1 January 2012.
