# COMPLIANCE WITH CARE QUALITY COMMISSION (CQC) REGISTERED MANAGER REQUIREMENTS

CQC registered general practices must have a registered manager (RM), except where the service provider is an individual who manages the service day-to-day and who is fit to carry on the service. Some single handed GPs will meet this criteria and will not need a RM. *Any GP practice registered with CQC as a partnership, or as an organisation, is required to have a RM*.

A practice must apply to register a manager within 12 weeks of the previous manager leaving. Where this does not happen the registered provider is in breach of Section 33 of the Health & Social Care Act. In these circumstances *the CQC can issue a fixed penalty notice* ( $\pounds 4k$  fine) or a prosecution (unlimited fine).

We recently received a letter from Beverley Cole, Head of General Practice – North Region, CQC informing us of CQC's current actions with regard to registered general practices without a RM. A letter is being sent to all providers without a RM, the process being as follows:

- Each CQC region will validate its list to make sure the provider needs a RM any that should not be on the list will be excluded.
- An inspector will check the system to make sure that no application is currently being processed for a RM if there is they will be excluded.
- CQC expects practices to have had a phone call once the lists are validated before a letter goes out.
- Once a response to the letter is received, this will be considered by CQC's legal team and managers, at which point a decision will be made as to further action to be taken.

# **REQUESTS FOR MEDICAL EVIDENCE IN SUPPORT OF BENEFIT CLAIMS AND APPEALS**

Further to the article in the July LMC newsletter, it has been brought to our attention that some Sheffield patients are being encouraged to request medical evidence from their GPs by Fightback4Justice, who state that the Department for Work and Pensions (DWP) do not contact GPs and Consultants during the appeal process, and often not at all during any stage of the application.

It is our understanding, following our negotiations with the DWP that systems are in place for the Centre for Health and Disability Assessments (CHDA) and Jobcentre Plus to obtain medical evidence when this is required.

If practices are aware of cases where medical evidence was not requested and should have been, it would be appreciated if anonymised details could be emailed to <u>manager@sheffieldlmc.org.uk</u> in order for us to monitor the situation and re-open negotiations with the DWP if necessary.

All GPs should have recently received a letter from Dr Mary Ramsay, Head of Immunisation, Hepatitis, Blood Safety and Countermeasures Response at Public Health England (PHE) noting that general practice will not be able to order any adult Hepatitis B vaccine stock until further notice.

# **DIGITAL CHILD HEALTH EVENTS PROJECT - ONLINE SURVEY**

NHS Digital, in collaboration with the Professional Record Standards Body (PRSB), is developing the information sharing requirements for the community child health record, which includes the Healthy Child Programme as part of NHS England's Digital Child Health Strategy.

The development of a standard will mean that information can be effectively shared electronically with health care professionals and made available to parents/carers through the personal electronic child health record (known as the e-red book). This will help ensure that key clinical information is available online when needed.

NHS Digital has commissioned the PRSB to consult with parents, carers, health and care professionals, industry and clinical informaticians on their draft requirements. An online survey is seeking views on the information content of the child health record to ensure that all data items are meaningful, relevant, complete and feasible to record/incorporate into clinical information systems: https://www.surveymonkey.com/r/W7LSKBL.
