CHANGE TO THE SUPPLY ROUTE OF PNEUMOCOCCAL POLYSACCHARIDE VACCINE FOR THE NATIONAL IMMUNISATION PROGRAMME

From 1 June 2021 Public Health England (PHE) will supply Pneumococcal Polysaccharide vaccine for the routine immunisation programme and the immunisation of people with underlying conditions - vaccine will not need to be purchased locally by practices.

The vaccine will be available to order from PHE from 1 June - see details in the <u>letter</u> issued by PHE and NHS England and NHS Improvement (NHSE/I) on 30 April 2021. The letter includes the clinical priority cohorts, which remain unchanged since 2017.

Any locally procured vaccine should be used, as much as this is possible, before 1 June. Once centrally procured vaccines are being used, no reimbursement claims can be made for the vaccine.

The British Medical Association (BMA) is in discussion with NHSE/I regarding the funding that will be released for the personal administration fee.

UPDATED GUIDANCE FOR HGV MEDICALS

Due to added pressures caused by the pandemic, a decision was taken by the DVLA in April 2020 to waive the medical requirement for a D4 licence renewal application for those aged 45 and over. Applicants were instead issued with a single, one-year licence.

After talks with the DVLA, the British Medical Association (BMA) has agreed to aim to accommodate D4 medical appointments for working drivers to make sure that drivers are available to the transport industry. Therefore, the BMA is encouraging practices to enable working drivers to have this medical examination when necessary, as much as public health guidelines and individual priorities allow.

The above excludes car driving licence renewals with small lorry C1, C1E (107) and minibus D1 (101) and D1 (101,119) entitlements issued before 1997, where these entitlements are used for driving large recreational vehicles rather than for working in the transport sector.

MATERNAL MENTAL HEALTH

As a result of the 2020/21 contract negotiations, additional funding was secured to support a dedicated postnatal check-up for new mothers. The National Childbirth Trust has now found, in their one year follow up survey, that new mothers are not yet always being given the opportunity for this important review, particularly to have the chance to discuss their own mental health.

Whilst this year has been exceedingly difficult, as practices plan for the coming year, the General Practitioners Committee (GPC) is encouraging practices to offer these dedicated appointments to all new mothers, and to do this at a different time from the regular baby health check.

SHINGLES IMMUNISATION PROGRAMME EXTENSION

As you will be aware, individuals become eligible for routine vaccination against shingles when they reach age 70, and all those aged up to and including 79 are now eligible to receive the vaccine until they reach age 80.

Individuals who are eligible for the shingles vaccination programme who turned 80 years during the pandemic and missed the opportunity to be vaccinated can now be vaccinated until 31 July. There are no contractual changes to this programme - the offer of vaccination is opportunistic, or if requested for the catch-up cohort.

GPs will continue to be reimbursed via the standard item of service fee, which should be claimed manually.

APPRAISAL 2020 SURVEY

RESEARCH TO INFORM STAFF TRAINING FOR DIGITAL DELIVERY IN PRIMARY CARE FOCUS GROUPS

Health Education England and NHS England and NHS Improvement (NHSE/I) would like to hear from GPs, practice nurses, practice pharmacists, practice managers and administrative staff about their experiences of delivering remote triage (navigating patients to the right person at the right time), online, telephone and video consultations in general practice.

Input from practices will be crucial in designing effective training to support all primary care staff and trainees to confidently work with these approaches.

90-minute virtual focus groups will be run in May and June 2021. If none of the focus group times are convenient, it is possible to arrange a time with the researchers to participate in an interview.
