MANAGING CHILDREN AND YOUNG PEOPLE'S IDENTIFIED HEALTH NEEDS

After lengthy negotiations spanning over three years, guidance has been published for schools and other settings entitled *Managing Children and Young People's Identified Health Needs.*

The guidance:

- has had input from a significant number of important stakeholders, including the Children and Young People's Directorate at Sheffield City Council (SCC), the Public Health Department, Head Teacher representatives, Sheffield Children's Hospital NHS Foundation Trust, school nurse representatives and Sheffield LMC.
- encompasses many important issues that are known to cause GPs concern and can be a cause of conflict between GPs, parents and schools.
- has been disseminated to all state mainstream primary, secondary and special schools under the auspices of SCC.

INSURANCE COMPANY REQUESTS FOR MEDICAL REPORTS/ACCESS TO MEDICAL RECORDS

The issue of insurance companies submitting a Subject Access Request (SAR) in place of a request for a GP Report (GPR) in support of sales of insurance continues to cause concern for practices. As a result, the LMC contacted the General Practitioners Committee (GPC) for their advice and requested an update on their negotiations with the Association of British Insurers (ABI).

Unfortunately, there is no sign of imminent resolution to this issue. However, the GPC has issued a helpful update which has been added to the LMC's guidance on this issue.

SEASONAL FLU PROGRAMME 2012/13: HOUSEBOUND PATIENTS

The LMC has received confirmation from Janine Thornton, Head of Rehabilitation Services, that Community Nurses will give flu vaccinations to housebound patients on their caseloads.

With the development of integrated care teams the LMC Executive will continue to try to negotiate an expansion to this role.

CHILDHOOD IMMUNISATION PROGRAMME PCV AND HIB/MEN C

The LMC has been made aware of a number of problems with practice immunisation claims for this particular part of the childhood immunisation programme.

Although these vaccinations appear on the 70% and 90% immunisation targets for QOF, practices are able to claim an *Item of Service* fee at the rate of ± 15.02 for each fully vaccinated child.

We would remind GPs and Practice Managers to check:

REIMBURSEMENT OF GP TRAINEE TRAVEL EXPENSES

GP Trainees who use their cars to conduct home visits during their placements are entitled to claim mileage expenses. The journey to and from work (up to 10 miles in each direction) can also be claimed, but only if a home visit is made that day.

With effect from 1 August 2007, all Sheffield GP Trainees entering practice placements receive their allowance under a mileage based system that rates Trainees as either standard or regular users, according to their level of usage.

Trainees and practices should ensure that they keep a record of any mileage claims for up to six years for tax purposes.

TRAVEL IMMUNISATIONS

The GPC's guidance *Focus on Travel Immunisations* has been updated (July 2012) as a result of the publication of Annex BA of the Statement of Financial Entitlements (SFE), which has resolved many of the difficulties in interpreting how the old regulations apply to current practice.

The guidance is contains sections on:

- Principles;
- Travel immunisations that must be given as part of NHS provision through GMS Additional Services (including the addition of Appendix 1, which gives more detailed information on travel immunisations available on the NHS);
- Travel immunisations that cannot be given as an NHS service;

• Travel immunisations that can be given as either NHS or as a private service;

Zostavax Shingles Vaccine

Despite a recent recommendation by the Joint Committee on Vaccination and Immunisation (JCVI) that people aged 70-79 years should be offered the Zostavax shingles vaccine, the Department of Health (DH) has confirmed that due to a shortage in supply, it will only be available privately for the time being.

Adverts have already appeared in the medical press stating that the vaccine is only available for patients over 50 who are able to pay for the vaccine. The GPC has heard reports that the manufacturer of Zostavax is contacting some practices directly, suggesting that practices contact their patients to offer this privately.

The GPC has written to the DH about their concerns over this arrangement, asking for assurance that the vaccine would be available on the NHS for patients aged 70-79.

Although the DH has confirmed that it intends to run a national vaccination programme for those over 70 years of age, until they have secured a sufficient supply of the Zostavax vaccine and is able to implement the JCVI's recommendations, the GPC's advice to GPs is that it is not recommended that this vaccine be given at the moment.
